SUBJECT:	Planning Commission Report to the Board Of Commissioners (for the Commissioner's Friday, December 18, 2015 meeting)

A meeting of the Planning Commission was held on Friday, December 11, 2015 from 3:00 p.m. to 5:40 p.m.

The Commission members in attendance were: Paull Hubbard, Jan Konesey, Joyce Lussier, Francis Markert, David Mellen, Harvey Shulman, Michael Strange, Lynn Wilson Absent: Brian Patterson

Also in attendance: Damalier Molina, Building and Licensing

 A Public Hearing of Application No. 1015-03 was held on the matter of the PARTITIONING REQUEST for the property located at 300 Bayard Avenue consisting of Lot Nos. 13, 14, 15 & 16, Block 30, into two (2) lots with Lot Nos. 13 & 14 becoming one (1) lot of 5,010 square feet and Lot Nos. 15 & 16 becoming one (1) lot of 6,969 square feet. The Partitioning has been requested by Jeffrey M. Garrison of Garrison Homes LLC, on behalf of Joseph A. Mathews, Executor of Nancy E. Mathews Estate, owner of the property.

Following a report from the Building Inspector, public comment and discussion by the Planning Commission, the application was conditionally approved. Vote: Unanimous.

- 2. The Chair reported that the final version of the State mandated five year review of the CDP which had been filed with the State Office of Planning Coordination in November had been approved by Constance Holland, Director, Office of State Planning Coordination.
- 3. The nominating committee recommended the following slate of officers for the following year: Chairman, David Mellen; Vice Chair, Michael Strange and Secretary, Francis Markert. Vote: Unanimous.
- 4. The Chair provided a status update on the Beach Walk (Baymart) project application. The Chief Building Inspector has deemed that the project, as currently submitted, was not ready to come to the Planning Commission for its Site Plan Review process because it was not compliant with the Zoning Code. The Building Inspector's decision is under appeal to the Board of Adjustment.

After a lengthy discussion, a resolution was passed instructing the Planning Commission Officers to explore how best to prepare a position paper that could be submitted to the Board of Adjustment on this matter of Zoning Compliance. Vote: 6 - Yea, 1 - Abstention, 1 - No.

5. At this time, there are no new Partitioning Requests that have been submitted. The Planning Commission will schedule its next regular meeting for January 8, 2016. This meeting will commence at 3:00 p.m.

Planning Commission Chairman David Mellen will attend and present the Planning Commission's report and is prepared to answer any questions that the Board of Commissioners may have concerning this report or other activities of the Commission.
