# **NEW BUSINESS**

The purpose of this meeting was to conduct an administrative appeal hearing pursuant to the Comprehensive Tree Ordinance (Chapter 253 of the Municipal Code of the City of Rehoboth Beach).

Appeal Hearing No. 1015-05 was requested by Kristen Waterfield, owner of the property located at 121 Laurel Street pursuant to Section 253-36 of the Municipal Code of the City of Rehoboth Beach, and pertains to denial of a request to remove six (6) trees and a determination of a mitigation fee in lieu of and/or a reduction of mitigation based on the survey.

Building Inspector Damalier Molina read his report which had been distributed with exhibits prior to the meeting. (Copies attached.) City Arborist Stacy Parsons granted approval for removal of (5) cedar trees totaling 49 inches and not requiring mitigation. The appeal seeks relief for removal of six (6) trees totaling 95 inches. No trees are proposed to be preserved. The minimum tree density required for this lot is five (5) trees. To meet the tree density requirement, two hardwood, two ornamental and one evergreen tree must be planted. Remaining are 27 trees to be approved as fee in lieu of mitigation.

Mr. Eric Brough of Garrison Homes represented Ms. Kristen Waterfield, owner of the property. The Japanese Maple is in the path of construction. He was in favor of keeping the Red Cedar at the rear of the property. The Arborvitae is in the path of construction. The Norway Spruce would also be removed.

Ms. Kristen Waterfield was open to replanting or mitigation. The tree planting plan would be based on the decision made by the Commission.

There was no public comment.

Chair Smith closed the public portion of the hearing and called for discussion among the members of the Parks and Shade Tree Commission.

Mr. Ned Kesmodel made a motion, seconded by Ms. Jane Wyatt, that the owner is allowed to remove all the trees except for the Red Cedar at the right rear of the property, plant five trees on the property and pay the mitigation fee in the amount of 3,000.00 to the City of Rehoboth Beach. (Smith – aye, Kesmodel – aye, Wyatt – aye, Hubbard – aye.) Motion carried unanimously.
