3 **AN ORDINANCE TO AMEND CHAPTER 206 OF THE MUNICIPAL CODE OF**  
4 **THE CITY OF REHOBOTH BEACH, DELAWARE, 2001,**  
5 **TO FURTHER REGULATE RESIDENTIAL POOLS**

7

8 **WHEREAS**, the lots within Rehoboth Beach’s residential neighborhoods are relatively  
9 small, typically fifty feet wide by 100 feet deep, and

10 **WHEREAS**, the City of Rehoboth Beach’s residential neighborhoods are populated by  
11 full-time residents, part-time residents and vacation rentals intermixed, and

12 **WHEREAS**, these uses have agreeably existed side by side through a delicate balancing  
13 of interests that has given the city a distinctively positive quality, and

14 **WHEREAS**, there has, in recent years, been an acceleration in the tearing down of the  
15 city’s historic cottages and replacing them with large houses which are utilized as vacation rental  
16 units many of which include unenclosed swimming pools, and

17 **WHEREAS**, the Mayor and Commissioners held a joint meeting with the Planning  
18 Commission on September 12, 2014 to discuss the impact of the increase in the construction of  
19 unenclosed swimming pools where citizens spoke of how vacation rental properties with a  
20 swimming pool had created a nuisance depriving them of the quiet enjoyment of their home, and

21 **WHEREAS**, the Mayor and Commissioners on October 17, 2014, instituted, on the  
22 strength of the testimony received at the meeting of September 12, 2014, a moratorium on the  
23 construction of new unenclosed swimming pools to allow the time to further investigate the  
24 impact of swimming pools used in conjunction with vacation rental units and, if found  
25 warranted, to adopt appropriate ordinances to address problems identified, and

26 **WHEREAS**, the Mayor and Commissioners have meet on a continuing basis since then  
27 to discuss issues surrounding vacation rentals, including the impact of unenclosed swimming  
28 pools, with public input an important part of these discussions, and

29 **WHEREAS**, the Mayor and Commissioners have found that when a property is utilized  
30 as a vacation rental, rather than occupied by full or part-time residents, the number and density of  
31 occupants increases, that unenclosed swimming pool use as part of vacation rentals is much more  
32 intense than would otherwise be expected, that the noise generated by those using a pool  
33 increases at a much faster rate than the increase in the number of people using it, and that the  
34 surface of the water contained in a pool tends to increase the impact of noise on adjacent  
35 properties, and

36 **WHEREAS**, the Mayor and Commissioners find that the proliferation of swimming  
37 pools used in conjunction with vacation rentals has and will diminish the quality of life for full  
38 and part-time residents in a dramatic and destabilizing way.

39 **BE IT ORDAINED**, by the Commissioners of the City of Rehoboth Beach, in session  
40 met, in the manner following to wit:

41 **Section 1.** Chapter 206 of the Municipal Code of the City of Rehoboth Beach, Delaware,  
42 2001, as amended be and the same is hereby further amended by placing Sections 206-1 and  
43 206-2 into an Article I titled “General Provisions” and placing Sections 206-3 through 206-14  
44 into an Article II titled “Construction and Licensing”.

45 **Section 2.** Chapter 206, Section 206-2, of the Municipal Code of the City of Rehoboth  
46 Beach, Delaware, 2001, as amended be and the same is hereby further amended by adding, in  
47 alphabetical order, a-two new definitions as follows:

48 **SWIMMING POOL, UNENCLOSED (UNENCLOSED POOL)**

49 A swimming pool not enclosed on all sides by walls and a roof or where the walls or roof  
50 are of materials or construction that fail to attenuate noise generated in and around the  
51 area of the pool.

52 **VACATION RENTAL**

53 The renting of a dwelling unit in any R1(S), R-1 or R-2 Zoning District for a period of  
54 120 or fewer consecutive days.

55 **Section 3.** Chapter 206, Section 206-14 of the Municipal Code of the City of Rehoboth  
56 Beach, Delaware, 2001, as amended be and the same is hereby further amended by deleting  
57 within Subsection A the first appearance of the word “Chapter” as it appears therein and  
58 substituting in lieu thereof the word “Article”.

59 **Section 3.4.** Chapter 206 of the Municipal Code of the City of Rehoboth Beach,  
60 Delaware, 2001, as amended be and the same is hereby further amended by a new Article II as  
61 follows:

62 **ARTICLE III**  
63 **VACATION RENTALS**

64 **§ 206-15. New pools.**

65 No unenclosed Private Rental Pool permitted after (date of adoption) shall be used at any time in  
66 conjunction with a vacation rental. The pool shall at all times the property is used for a vacation  
67 rental be covered by a locked cover

68 **§ 206-16. Existing pools.**

69 No unenclosed pool that was permitted or constructed on or before (date of adoption) where no  
70 valid City rental license existed for the related property on (date of adoption) shall be used at any  
71 time in conjunction with a vacation rental. The pool shall at all times the property is used for a  
72 vacation rental be covered and inaccessible. ~~by a locked cover.~~

73 **§ 206-16. Future use of pools.**

74 Notwithstanding anything contained in this Chapter to the contrary no unenclosed pool shall be  
75 used at any time in conjunction with a vacation rental after January 1, 2018. Thereafter the pool  
76 shall at all times the property is used for a vacation rental be covered by a locked cover.

77 **§206-17. Violations and penalties.**

78 **A. The property owner shall at all times be responsible for compliance with this Article.**

79

80 **B. Any violation of this Article is declared a civil offense pursuant to Chapter 126 of the**  
81 **Municipal Code of the City of Rehoboth Beach. Any person who violates this Article shall**  
82 **pay a civil assessment of \$250. Each day such violation continues after notice of violation**  
83 **has been given to the offender shall be considered a separate offense.**

84

85 **C. In addition to those authorized by §126-2, any City employee authorized by the City**  
86 **Manager to enforce this Chapter may issue a citation to any person violating this Article.**

87 **Section 4.** If any provision of this Ordinance shall be deemed or held to be invalid or  
88 unenforceable for any reason whatsoever, then such invalidity or unenforceability shall not affect  
89 any other provision of this Ordinance which may be given effect without such invalid or  
90 unenforceable provision, and to this end, the provisions of this Ordinance are hereby declared to  
91 be severable.

92

93 **Section 5.** This Ordinance shall take effect immediately upon its adoption by a majority  
94 vote of the Commissioners of the City of Rehoboth Beach.
