The purpose of this Special Meeting was to:

- A. Conduct a strategy session where the City's negotiating team will update the Commissioners on the status of the negotiations underway to secure a new contract with the bargaining unit that represents the City's police officer. This item may include an Executive Session since it involves a strategy session in regards to collective bargaining as permitted by 29 Del.C. Section 10004(b)(4).
- B. Conduct a strategy session to include receiving legal advice and opinion from the City Solicitor in regard to the pending litigation in Myslewski vs. City of Rehoboth Beach Case No. 1:13-cv-00891-RGA. This item may include an Executive Session since it involves the Commissioners receiving legal advice and opinion from an attorney regarding pending litigation as permitted by 29 Del.C. Section 10004(b)(4).
- C. Review and discuss with the City Manager her performance to date and the competency and abilities of other City employees. This item may include an Executive Session where personnel matters in which the names, competency and abilities of individual employees were discussed, as permitted by 29 Del.C. Section 10004(b)(9).
- D. Conduct a strategy session in regard to the grievances filed by the General Teamster Local Union 326 which grievance concerns the promotion of lieutenants and has been submitted to arbitration by the union. This item may include an Executive Session since it involves a strategy session in regards to pending litigation as permitted by 29 Del.C. Section 10004(b)(4) and included the discussion of the names, competency and abilities of individual employees, as permitted by 29 Del.C. Section 10004(b)(9).
- E. Conduct a strategy session to include receiving legal advice and opinion from the City Solicitor in regard to the pending litigation in Kuhns vs. Hiler, Civil Action No. 7586-VCG, in which the City is a third-party defendant. This item may include an Executive Session since it involves the Commissioners receiving legal advice and opinion from an attorney regarding pending litigation as permitted by 29 Del.C. Section 10004(b)(4).

Mayor Cooper noted that all items would be conducted in Executive Session.

Commissioner Bill Sargent made a motion, seconded by Commissioner Stan Mills to move to Executive Session for the five items as listed on the agenda at 8:05 a.m. Motion carried unanimously.
